Funding Alternative Fuel Activities

A wide variety of funding sources is available for alternative fuel activities. The Clean Cities Web site maintains updated information on funding resources and tips for pursuing those resources at www.cities.doe.gov/funding.shtml. This fact sheet summarizes major funding opportunities and suggests avenues for finding additional funding.

In addition to seeking conventional funding sources, it is important for Clean Cities coalitions to explore opportunities unique to their areas and to link diverse partners. For example, Kentucky's Commonwealth Clean Cities Partnership initiated a project to convert six buses at Mammoth Cave National Park to propane. From this modest beginning, the coalition established a network of new projects and funding sources with partners that included the National Park Foundation, the U.S. Department of Energy (DOE), the Propane Education & Research Council, propane and car dealers, an equipment installer, and a nationwide resort company.

This is only one of many creative partnerships built by Clean Cities coalitions nationwide. Active Clean Cities participation maximizes funding success. If your company, organization, or fleet is not yet involved in a Clean Cities coalition, contact your local coordinator to discover the many benefits of membership.

DOE State Energy Program (SEP) Grants—Clean Cities Program Category

Alternative Fuel Activities Funded

Acquiring commercially available AFVs, including school buses, and AFV infrastructure. Providing cost sharing toward projects that support coalition activities.

Eligibility and Application Procedures

Designated Clean Cities coalitions are eligible. Solicitations are posted on the DOE e-Center. Applications must be routed through local Clean Cities coalitions then submitted to DOE by the state energy office (or its equivalent) for the

state in which the project will occur. Contact your state energy office for specific rules and deadlines.

Congestion Mitigation and Air Quality (CMAQ)

Funded by the Federal Highway Administration and Federal Transit Administration

Alternative Fuel Activities Funded

Switching transit vehicles to alternative fuels, purchasing vehicles and fueling equipment for other public agencies and private companies. For CMAQ purposes, an "alternative" fuel must reduce emissions to be eligible (includes natural gas, ethanol, methanol, electricity, and propane).

Eligibility and Application Procedures

Funds must be spent in nonattainment or maintenance areas as designated by the U.S. Environmental Protection Agency (EPA). Funds are available to a wide range of government and nonprofit organizations, as well as private

entities contributing to public/private partnerships, but are controlled by local Metropolitan Planning Organizations (MPOs) and state Departments of Transportation. The process for obtaining CMAQ funds varies. Generally, coalitions must establish a relationship with the local MPO and have projects included in the MPO's Transportation Improvement Program.
